Dear Sir or Madam,

By letter dated 10 March 2020, the Federal Maritime and Hydrographic Agency (BSH), on behalf of the Federal Ministry of the Interior, for Building and Community (BMI), which is responsible for spatial planning in the German Exclusive Economic Zone (EEZ), notified the neighbouring countries of the North Sea and Baltic Sea of the revision of the spatial plans for the EEZ in the North Sea and Baltic Sea.

There was an early opportunity to comment on the concept for revising the plans and the draft investigation framework for the strategic environmental assessment.

An early international consultation meeting was held on 24 April 2020. The investigation framework for the strategic environmental assessment was adopted on 17 September 2020. The document is available on the BSH website in English, Danish and Polish at this link:

The draft revised maritime spatial plan and the environmental reports were then prepared and published on 25 September 2020. I kindly ask the responsible spatial planning authority or the designated ESPOO contact point to make the consultation documents available in an appropriate form to the public concerned in the neighbouring state. In particular, I kindly ask you to indicate

- where, in what form and for how long the documents will be made available to the public
- which German authority, in what form and within what period of time the public concerned in the other country may submit comments,
- that the public participation procedure excludes, at the end of the period laid down, all comments for the procedure,
- that an international consultation meeting will take place on 27 January 2021 as an online conference in English and that dial-in details will be provided after registration.

Authorities and the public concerned in neighbouring countries will have the opportunity to comment on the documents until 15 January 2021.

I would like to point out that any comments received after this date will be excluded.
